

## **Sisters Transportation and Ride Share Transport Authorization, Liability Release and Indemnity Waiver**

Sisters Transportation and Ride Share (STARS) as an Action Team of Age Friendly Sisters Country (AFSC) hereby grants to the undersigned the privilege of one or more transports, free of charge, for the Passenger's convenience in obtaining, assisting with, or returning from medical treatment or diagnosis under the following terms and conditions:

1. The undersigned is a passenger and/or the parent or legal guardian of one or more minor or disabled passengers and executes this release voluntarily to bind themselves as a passenger and/or to binds all minor or disabled passengers of whom they are parent or legal guardian (all of the foregoing are referred to herein collectively as the "Passenger").
2. The Passenger understands that the driver, operators, owners and lessors of the vehicles in which the Passenger will ride (all of the foregoing are referred to herein collectively as the "Volunteers") are volunteering their services, time, skills, vehicles, and other related costs and expenses for the Transportation, and that they are not reimbursed for their services except as allowed for by the IRS for mileage reimbursement.
3. The Passenger understands that STARS and the Volunteers are relying on the Passenger's release for their agreement to provide the Transportation.
4. The Passenger also acknowledges that the Passenger is riding in the vehicles voluntarily of Passenger's own free will and desire.
5. In consideration of the furnishing of the Transportation, services, time, skills, vehicles, and other related costs and expenses being arranged and provided, the Passenger hereby agrees to forever release, discharge, indemnify, defend and hold harmless the Volunteers, STARS, AFSC and each of their respective divisions, parents, subsidiaries, wings, member organizations, affiliates, chapters, officers, directors, agents, employees, volunteers, insurers, heirs, assigns and successors in interest, and any and all entities who referred me to STARS from any and all claims, demands, liability (under the law of any state or country), fees, expenses, and costs of any kind whatsoever, including attorneys' fees, that the Passenger may have or claim to have on account of or in any way related to or, directly or indirectly, arising from the proposed or actual Transportation, the cancellation or delay of the Transportation, and/or the failure to provide initial or return Transportation of the Passenger. The Passenger further agrees not to sue on any claim, or instigate any action, related to or arising out of the Transportation.
6. The Passenger's release specifically includes any form of economic damages, costs and expenses, and covers all injuries, deaths, and conditions of health, whether or not immediately apparent, following, arising out of or related in any manner to the Transportation, or which may at any time thereafter develop.
7. As evidenced by the signature below, the Passenger regards the Transportation, services, time, skills, vehicles, and other related costs and expenses being furnished to the Passenger by the Released Parties as significant, material, and valuable consideration in exchange for this release, and the Passenger values this consideration as a significant, material factor in the Passenger's well-being and physical prosperity.

8. The Passenger has read and fully understands this release. The Passenger has talked with a Ride Dispatcher or other persons associated with STARS about questions concerning the Transportation. In connection with any portion of this release that the Passenger did not understand, the Passenger understands that the Passenger had, and continues to have, the right to obtain legal advice from an attorney of the Passenger's choice and that the Passenger has been encouraged to seek such legal advice.

This release shall be binding upon the Passenger, the Passenger's parents and/or guardians, and the Passenger's heirs, assigns and successors in interest and any companion rider who may accompany the passenger. This release may be enforced by any of the Released Parties, each of whom individually, along with their respective heirs, successors and assigns, is a third-party beneficiary of this release. The Passenger acknowledges that this release shall be governed and interpreted by the laws of the State of Oregon.

### **PASSENGER INFORMATION:**

I understand and agree that this agreement will remain in effect until revoked in writing by me or by an authorized signatory of Sisters Transportation and Ride Share (STARS). This agreement cannot be modified. I understand that this agreement will apply every time I am transported by any driver who is affiliated, trained, and scheduled by STARS without requiring me to sign an additional agreement for each ride.
